 - A. Course Applications, Business

As the course is written, a student can receive a passing grade in the paper and not have participated adequately in the internship and still pass the course.

2. TIBCUS 460 African-American Religious History, permanent new course Resources: Is the last sentence relevant to the course? If not, delete. If so, the relevancy should be lined with something in the course syllabus.

3. TIBCUS 465 African-American History 1945-Present, permanent new course & TSMUS 467 United States History 1945-Present, permanent change

Note editorial change for TIBCUS 465Make a clear distinction between the two courses.

1. THLTH 485 Critical Issues in Global Health, permanent new course Justification: Note editorial change.

Catalog Description: Add "X" by I&S. Double space description.
