Ellen Moore motioned to remove the prohibition placed on FC to only present to us 3-department models so that the [faculty] council may present and share with us the other 3, 4, and 5 department models on which they have been working; Rubén Casas seconds. [We need to deal with the motion that is already on the floor.]

1. Introductions, Ground Rules, Land Acknowledgment, and Safety Briefing.

a. With a quorum present, Faculty Council Chair Ben Meiches called the meeting to order at 12:36 and the group took a moment to reflect on the SIAS Ground Rules, Land Acknowledgment, and Safety Briefing before beginning the business of the faculty meeting.

2. Consent Agenda: Approval of Minutes.

a. There were many objections to the minutes of the November 17, 2023 meeting. Divya McMillan moved that we amend the minutes; Rubén Casa seconded. [Yes: 66; No: 5; Abstain: 12]

- b. The requested amendments are in red:
 - 1. Personal comments made by Faculty Council Chair Ben Meiches stating that he does not have the bandwidth to revise the RCEP proposal; that he took his course releases this quarter; there are health concerns in his family; he is committed to interdisciplinarity illustrated by his support of deceased colleague John Finke; and maybe we no longer want his leadership. [Submitted via email by Luther Adams Free Man of Color; these comments are not in the notes taken at the meeting.]
 - 2. **Motion:** Randy Nichols makes a motion that the votes not be read aloud at the end of the meeting and that there is no editorializing regarding the vote; seconded by Huatong Sun.
 - 3. David Coon moved to accept the RCEP proposal as presented discuss the RCEP Proposal; Jim Gawel seconded.
 - 4. Why are we moving forward with restructuring before addressing climate issues? Upper leadership has said that we have to figure out the structure before we can address the climate.
 - 5. As CAC faculty members were concerned about attending another meeting, Luther Adams Free Man of Color moved to adjourn the meeting; Sushil Oswal seconded; no discussion is allowed. [Yes: 56; No: 6; Abstain: 5]
- c. Julia Eaton moved to accept the minutes as amended; Haley Skipper seconded; [Yes: 58; No: 5; Abstain: 12]

3. RCEP Report.

- a. Continuation of the discussion from the November 17, 2023 meeting:
 - 1. There are deep concerns about the 3-department model that has been presented.
 - 2. Is it possible to put a time limit on this: Many are weary of this process.
 - 3. Ellen Moore motioned to remove the prohibition placed on FC to only present to us 3-department models so that the [faculty] council may present and share with us the other 3, 4, and 5 department models on which they have been working; Rubén Casas seconds. [We need to deal with the motion that is already on the floor.]
 - 4. Is it possible to address climate at the same time as restructuring?
 - 5. Climate was discussed at a recent DAC meeting.
 - 6. It's unfortunate the way the EGL major has been treated and that it might be divided.
 - 7. In the previous meeting, David Coon moved to accept the RCEP proposal as presented; Jim Gawel seconded. [Yes: 18; No: 53; Abstain: 11]
 - 8. Bonnie Becker motions for a 5-minute break; there is no second.
 - 9. Danica Miller reads Ellen Moore's motion to remove the prohibition placed on FC to only present to us 3-department models so that the [faculty] council may present and share with us the other 3, 4, and 5 department models on which they have been working; Randy Nichols seconded.

7. Discussion:

- a. If faculty or divisions have additional models, they should bring them to their Faculty Council rep.
- b. There is concern about having two large divisions and two smaller ones; concern about the function and protection of the smaller units.
- c. Many feel that we are too big to function as we've been trying to function.
- d. Addressing climate is necessary.
- e. Randy Nichols moves that until the RCEP is completed that we keep the promotion and merit process as it is; there is no second.
- f. Is it possible to take a couple of quarters to address climate?
- g. We voted last Spring to move forward with restructuring as part of addressing the
- h. The longer we push this out the more likely it is that we will not be able to make the decision ourselves.
- i. This is not meant to be a deliberative body; Faculty Council is a deliberate body; we are supposed to trust Faculty Council to bring forward motions and have our elected representatives make decisions; we are in this situation because we don't trust the process.
- j. Demographic data can't be used to make decisions; that data has restrictions even at the campus level.
- k. Randy Nichols withdraws his motion.
