a. Finance Discussion with Sylvia from Finance & Administration

Sylvia is unable to make it today, but Cherie Berthon (the Associate Vice Chancellor for Planning and Budget) talked about the Budget Development Campus Kickoff for 2024-2025.

State Budget Process and timing which shows biennium and calendar years.

Washington State Budget Framework which shows operating budget which is \$134 billion. This section showed a bar graph which has "other human services and public schools" on high budget. Higher Ed Operating Budget at \$18 billion.

UW FY Operating Budget which shows a pie chart of the academy budget sources by major area.

UW State and Tuition Funder per FTE had a line graph for tuition revenue per FTE, State Funding per FTE and Total Funding per Student FTE.

UWT Fiscal Context which shows a bar graph showing trends in tuition and state funding from years 2018-2019, through 2022-2023 and had Net Tuition Collections, State Allocation from OPB and provisos from Legislature. Another slide showed a bar graph of the General Operating Fund Expenditures in Mllions and Student Enrollments.

Operating Budget Process Timeline which showed the Financial Transformation Milestones UW Tacoma Finance, UWT Budget Process, UWS Office of Planning and Budget.

Showed the FY 2025 Operating Budget Development which shows the Core Revenue such as State Allocation, which had the Estimated FY25 Base Allocation from OPB, Estimated Stat Funds for 3% wage increase and legislative Provisos. It also shows the Tuition and Overhead which had 2024-2025 Tuition Project – Operating Fee Only, Estimated Summer Tuition Collections and UWT Overhead. The total FY25 Estimated Revenue was 89,759,606. The Estimated FY 2025 Core Expenditures had FY Core Operating Budget, FY25 Mandatory Expenditure Increases, and Total FY25 Estimated Base Operating Expenditures. Additionally showed the FY25 On-Going Budget Recommendations, Total FY25 Recommended On-Going Operating Budget, FY25 One-Time/Temporary (Reserve) Recommendations (Requested 3,259,049) and Total FY25 UWT Operating Budget Recommendation.

Talked about highlights looking at items recommended for ongoing funding such as BA Education program, Director of Tribal Relations, and Increases in Fixed Costs/Compliance Requirements. The document also had recommended one-time reserve funding such as expanded hours in the library, faculty mentoring, and equity and inclusion.
