
This does not require fully egregious enemies to be effective. Merely dehumanizing other groups is enough to influence psychological bias and the delusion of escaped accountability.

SURGERIES DONE TO INTERSEX CHILDREN ARE PURELY COSMETIC, FOR THE COMFORT OF SOCIETY, DESPITE ADVERSE RISKS TO THE CHILD THEMSELVES.



#### DO YOU REALLY BELIEVE HARMING CHILDREN IS BAD?

Despite proposing laws because 'children are too young to advocate for themselves', supporters for bans on gender affirming care for transgender youth in recent years have exceptions made for cutting intersex children (Sosin, 2023).

Even when presented with research or demonstrations about how altering the intersex child could negatively impact them, most people only feel pity for that intersex person, or about that surgery, and not for intersex people as a group

(Hegarty & Smith, 2022).

#### WHAT IS HAPPENING CURRENTLY?

On Jan. 16, 2025, the HHS report titled Advancing Health Equity for Intersex Individuals released. This was the first-ever U.S. government publication that fully acknowledged the existence of, the specific discrimination of, and harm suffered by intersex people, and included recommendations for change.


On Jan. 20<sup>th</sup>, with an executive order, not only was this removed, but all mentions of 'intersex' were removed from all federal sites. For 4 days intersex people existed in this country according to the government even though they have always existed.

Government documents currently reflecting intersex adult genders, even with medical substantiation, under this executive order, could be forcibly reverted to whatever gender they were described to be at birth, whether accurate or not.
