  - Vice President Watkins asks what is most important to Senate; ideas include an open house, a Senator forum, getting more involved with the administration side of things to build connections.
  - Upcoming projects include tabling events (particularly in the WPH or Husky Commons), getting Senate involved with student comments, visiting classrooms, and an upcoming town hall meeting in the Dawg House.
  - Pre-major Senator \*\*\* requests planning an event to involve students since there is a wide variety of students within their purview, so they'd like to coordinate an event
  - Vice President Watkins mentions a meet-and-greet night with students, faculty, admin, and senators may be a positive event to plan.

#### • [Executive Session]

- As per the ASUWT Bylaws 1302.02, the ASUWT Senate will interview the ASUWT Vice President, Rae Watkins, to make an educated decision on whether to proceed with a vote to appoint the ASUWT Vice President, Rae Watkins, into the vacant ASUWT President position.

  - Senator Gonzales motions to extend the offer of hire to Rae Watkins,
     Senator Naamat seconds
  - o All present Senators (5) approve the motion, and it is adopted
- [Roll Call Vote]: Hiring the ASUWT Director of Graduate Affairs
  - Senator Gonzales motions to table this for the next meeting, Senator
     Naamat seconds
  - Motion is adopted 4-0-1
- **[Discussion]:** Senator Barnes presents the process for post-registration costs appearing on MyUW before students register for certain classes
  - Senator Barnes shares a document regarding accessibility of registration materials to be read in Senators own time, and upon request to him
  - Breakdown of steps:
    - Identify relevant faculty that can assist
    - Identify the issue for your specific department (accessibility, homework key visibility, additional required purchases) that are not explicitly mentioned before registration
    - Workshop solutions
    - Additionally: review survey data from past surveys and join in discussion within your student bodies
    - Propose the solution to follow
    - Record your findings and outcomes, please share results with the Senate to continue documentation of accessibility to registration materials
- [Discussion]: Senator Scholten presents information regarding the UW Tacoma YMCA's previous and continued efforts to support the UW Tacoma student body, provided by the UWTYMCA manager
  - Senator Naamat motions to table this topic, Senator Barnes seconds
