

TUITION REDUCTION FOR MILITARY CONNECTED – FOR ELIGIBLE SPOUSE/CHILD

The Washington State Legislature has defined the eligibility and extent of Military-Connected individuals to qualify for resident tuition rates. This form is for students who DO NOT QUALIFY for standard WA state residency. **To assist with eligibility determination, please read the following, indicate eligibility (one only), and submit the signed form along with requested documentation as designated no later than the 30th day of the quarter.** If approved, you will be classified to receive in-state tuition though may not be eligible to receive financial aid benefits as a Washington state resident with a bona fide domicile.

MILITARY DEPENDENTS Spouses and children who meet one of the following qualify for resident tuition.

- Dependents of active duty members stationed in Washington or dependents of Washington National Guard members (National Guard members do not have to be on active duty).
Continuously enrolled or Admitted to an institution before the re-stationing and enrolled in the institution for the term the student was admitted
- Dependents who are **entitled** to transferred post-9/11 GI Bill benefits based on their relationship to someone on active duty. The dependent does not need to be actively using educational benefits to qualify.
- Dependents who are **entitled** to VA educational assistance benefits based on their relationship to veteran. Neither the dependent nor the veteran need to live in Washington. Dependents must also meet all of the following:
They must enter school within three years of the veteran's separation from the military **and** the veteran must have had at least 90 days of active duty service **and** the veteran must have separated from the military with any period of honorable service (separation does not have to be from active duty).
- Dependents who are **entitled** to VA educational assistance benefits, such as DEA or the Marine Gunnery Sergeant John David Fry Scholarship
- Dependents of a veteran who separated from the military with at least ten years of honorable service (separation does not have to be from active duty). The dependent does not have to be eligible for or be using VA educational benefits to qualify. Dependents must meet both of the following:
The student must enter school within three years of the veteran's separation from the military **and** the veteran must have had at least 90 days of active duty service.

I certify that I meet the criteria listed and will notify the University of Washington if my status should change. I will submit copies of any pertinent materials including: **Orders, DD214 Member 4, Certificate of Eligibility, Terminal Leave Orders and military ID.**
